



## **OFFICIAL RULES FOR THE SHIRLEY'S WAY QUEEN OF HEARTS DRAWING**

*Shirley's Way is a non-profit 501c3 90-1024077 Gaming License # ORG0002527 PRIZE MUST be Claimed within 30 days after the day the winning ticket is pulled. Unclaimed prizes from Queen of hearts will be donated back to Shirley's Way*

**The drawing is held every Monday night at Khalil's on Dixie at 8:30 p.m.**

### **WHAT IS THE QUEEN OF HEARTS?**

1. A game board containing 54 cards (a standard deck and 2 Jokers, placed face down, numbered and sealed) purchased from a certified gaming vendor, will be displayed at Khalil's in a locked case with the Queen of Hearts as the "Jackpot Card."
2. The Queen of Hearts drawing will occur every **Monday evening at 8:30 p.m. with one ticket drawn, starting on July 15, 2019 at Khalil's, 10966 Dixie Highway, Louisville KY 40272.** Ticket sales stop at 8:15 p.m. on Monday nights.
3. Shirley's Way will fund the initial pot with a Jackpot of \$10,000.00. Tickets are \$2 each with no limit on the number of tickets that can be purchased. All tickets sold are double stub tickets so you may print your name, phone number and CARD number to turn in and retain a stub for your proof of purchase.

### **HOW DO YOU PLAY?**

4. The card number on the drawn ticket will be flipped. If the card flipped is the Queen of Hearts, the **WINNER** will receive fifty (50%) of the jackpot. The remaining portion of the funds will go to Shirley's Way to fund its charitable mission. IF a Joker is flipped and IF the ticket holder is **PRESENT** ( on the property at Khalil's at the time of the drawing) they will win 10% of the current pot total and the game will end. The remaining pot total will roll over to a NEW board with 54 cards.

### **WHAT IF NOBODY WINS?**

5. If the card flipped is **NOT** the Queen of Hearts and the ticket holder is **PRESENT** and on the property at Khalil's at the time of the drawing, he or she will receive the following consolation prize for their corresponding upturned card: 10% of current pot total for a Joker, \$500.00 for a face card or Ace, and \$250.00 for all other cards.
6. If the card flipped is **NOT** the Queen of Hearts, all the tickets will be removed from the cylinder and will be destroyed per the Kentucky Charitable Gaming Commission Rules and Regulations.  
**TICKETS WILL NOT CARRYOVER FROM ONE WEEK'S DRAWING TO THE NEXT. A NEW TICKET MUST BE PURCHASED FOR EACH WEEK'S DRAWING TO PARTICIPATE. THE TICKET TO PLAY**
7. If you are **NOT** present for the drawing and **NO** card number is written legibly on the ticket drawn from the cylinder, then a random number will be chosen to be turned from the board on your behalf by a Shirley's Way representative. If you are present and **NO** card number is written legibly on the ticket drawn from the cylinder, then you will inform the representative of Shirley's Way Queen of Hearts the card number that you would like to have turned.
8. If you are **NOT** present for the drawing and card number written on the ticket drawn from the cylinder has already been turned, then a random number will be chosen to be turned from the board on your behalf by a Shirley's Way representative. If you are present and card number written

on the ticket drawn from the cylinder has already been turned, then you will inform the representative of Shirley's Way Queen of Hearts the card number that you would like turned.

9. For group purchases, in the event of a disagreement amongst the purchasers, the only obligation of Shirley's Way is to issue the prize in the name of the person listed on the winning ticket.

#### **WHAT IF I WIN?**

10. All **WINNERS** are responsible for paying the applicable taxes on any prize they win. All prizes over \$600.00 will be paid by check and Shirley's Way will issue the WINNER a W2G, which will require the **WINNER** to provide her/his social security number. NO prize will be paid until the W2G information is provided. If a **WINNER** is unwilling to fill out a W2G, the prize will revert back to Shirley's Way. For prizes of \$5,000.00 or greater, Shirley's Way is required to withhold the IRS backup withholding tax, currently set at 24% per IRS rules and regulations.

11. Shirley's Way reserves the right to require any **WINNER** to complete an affidavit of eligibility prior to payment of any prize.

12. To claim a winning prize, the purchaser must provide the ticket stub from the other half of the ticket and a valid government issued identification.

#### **THE FINE PRINT**

13. Each card selected and turned will have the drawn ticket attached to it and that card will remain posted on the board for the duration of the game. Once the "Queen of Hearts" is selected, the board will no longer be in play and Shirley's Way will solely determine its use.

14. Any ticket purchased and returned to Shirley's Way for play, shall become the sole property of Shirley's Way and the **WINNER** waives any right to possession of the ticket.

15. All **WINNERS** agree that their image and identity may be used by Shirley's Way for advertising purposes or any other lawful purpose without compensation.

16. You must be 18 or older to play. If a **WINNER** is not 18 or older the prize is forfeit and shall revert to Shirley's Way.

17. Shirley's Way reserves the right to list any **WINNER** on any subsequent advertising, into perpetuity, without compensation.

18. Shirley's Way reserves the right to discard any online purchase if it determines, in its sole discretion, that the purchase may have been affected by hacking, security breaches, bugs or any other type of online tampering. Such purchase may be discarded and ruled ineligible after a winning draw only upon good cause and within 48 hours of the drawing.
